Those moments taught me perseverance, patience, and resilience—qualities that have shaped my character and allowed me to grow as a leader and

I love this country and this city. While many of my friends have moved to red states like South Carolina, Florida, or Idaho, I've chosen to stay in Spokane, my hometown, to fight for its future. When I arrived in 1998, Spokane was a conservative stronghold, and I want to help restore those values. I believe in working to make this community stronger, more united, and true to the principles that built this great nation.

#### List any relevant experience, leadership, or service.

For most of my life, I've been a business owner, so working with and leading a team comes naturally to me. My current business is a logistics company specializing in the nationwide transport of exotic and classic vehicles. For the past five years, I've overseen drivers, broker relationships, the dispatch department, and maintenance operations, while personally managing accounting to ensure everything runs in synchronization and cash flow remains seamless.

Before this, I founded a fintech startup called XpenseOne, a digital expense management solution. Despite having no technical background, I built a stellar team, raised nearly \$1.5 million from local investors, and successfully launched the company. This venture involved collaborating with financial institutions and banking technology providers, as well as presenting at some of the largest banking conventions. Navigating the complex compliance requirements in the financial industry taught me invaluable lessons about adaptability and innovation.

### Describe your duty to the office you are running for and how you will achieve success.

As Spokane County Treasurer, the role involves several key responsibilities: collecting taxes, disbursing funds and making payments, and serving as a fiduciary for the county's accounts to ensure safe and maximized returns on investments.

My job as Treasurer is to thoroughly understand every aspect of these workflows, collaborate with the existing team, and ensure all goals and tasks are executed effectively. The immediate objective is to maintain or exceed the key performance indicators achieved by my predecessor. Over the long term, I aim to surpass these benchmarks by improving tax collection efficiency and increasing the county's return on investments.

# What does success look like for this position and what key performance indicators should voters use to evaluate you?

Success as Spokane County Treasurer means ensuring the county's financial operations are efficient, transparent, and aligned with the best interests of taxpayers. My ultimate goal is to maintain and improve the county's financial health while fostering trust and accountability with the community.

Key performance indicators (KPIs) voters should use to evaluate my performance include:

Tax Collection Efficiency: How effectively taxes are collected, including improvements in collection rates, reduced delinquencies, and streamlined processes that make it easier for residents and businesses to meet their obligations.

Return on Investments: The safety and performance of the county's investments. Voters should expect consistent, secure growth in returns that maximize county resources without taking undue risks.

Cost Management: Operational costs of the Treasurer's Office. Success includes ensuring that expenses are kept low without compromising service quality.

Transparency and Communication: Accessibility and clarity of information shared with the public. This includes timely reporting on the county's financial status, investments, and tax collection updates.
