It's Time to Demand Justice and Accountability

In defense of individuals who were falsely charged in connection with the January 6, 2021, "Stop the Steal" protest, the event and its aftermath represent a profound miscarriage of justice driven by political vengeance rather than evidence of criminality. These United States citizens were exercising their <u>God given</u> First Amendment rights to challenge the 2020 election's legitimacy, and except for the few agitators, they were not violent insurrectionists bent on overthrowing the government.

Many of us listened to President Donald Trump's speech that day and his urging supporters to "peacefully march" to the Capitol was a call to civic action, not lawlessness. We watched some enter the Capitol violently, but most went in spontaneously or at the invitation of Capital Security Personnel and most, if not all, were unaware they were walking into what is now undeniably proven to be a well-conceived political snare.

Thanks to patriots like Tucker Carlson, Dan Bongino, and FBI Director Kash Patel, there is a trove of publicly available evidence including thousands of hours of raw video that destroys the State Driven Media Narrative and implicates the federal government, including the Department of Justice (DOJ) and FBI, in an operation to weaponize the legal system for political purposes.

The J6 political operation is a dragnet that unfairly targeted supporters of President Donald J. Trump. Minor (misdemeanor) offenses like trespassing and disorderly conduct were inflated by federal prosecutors and activist judges into harsh and inhumane punishments, including outrageous extended jail sentences. When contrasted against the absence of "justice" for the violent protests that occurred in 2020 beginning with Minneapolis burning following the George Floyd incident in May and continuing throughout the summer (Kenosha, Portland, Seattle and Washington DC) it's clear that "Equal Justice for All" in this country is something we all want but those we elect to represent us either aren't able to deliver or willing to risk their political careers to fight for this fundamental tenant of Freedom.

HB 1380: Undermining Local Control and Spokane's Voter-Approved Laws

House Bill 1380 introduces an ambiguous and problematic standard that would significantly weaken Spokane's ability to enforce its voterapproved anti-encampment laws. The bill mandates that any local restrictions on public camping be "objectively reasonable," but it fails to clearly define what that means or who gets to decide. This vague language invites legal challenges and makes it harder for cities to enforce laws that their residents support.

Spokane voters overwhelmingly passed Proposition 1 in 2023 to prohibit encampments near schools, parks, and public spaces where families and businesses have been directly impacted. HB 1380 threatens to override that decision, making enforcement far more difficult and potentially unenforceable. Instead of respecting local decision-making, state lawmakers are attempting to impose a one-size-fits-all approach that ignores the unique challenges Spokane faces.

This bill does nothing to address the root causes of homelessness, such as increasing rehabilitation facilities and funding or expanding mental health services. Instead, it weakens local governments' ability to maintain public safety and uphold the will of their constituents. Spokane residents made it clear that they want stronger enforcement against illegal encampments.

HB 1380 disregards that choice and should be firmly opposed.

Property Rights

Freedom is an interesting concept. We profess, as Americans, to believe in freedom while regularly going about to restrict it. Perhaps it is time to step back an analyze what freedom actually means—or at least what it should mean. True freedom means only that we have the God-given right to choose. That would then be followed by complete accountability. We do not live in that world.

In relationship to freedom, property rights come with their own set of conundrums. If we had true freedom, property owners would be able to use their property for whatever end they wished. Again, they would have to have full accountability for their usage. For example, if I used my property to create illegal drugs, should I lose my property rights as punishment? Or should I be jailed and/or receive fines for my criminal activity? These are the kinds of questions that are settled by the populous in a civilized society.

None of these questions have easy or simple answers, but the focus should be on always maintaining every bit of freedom as possible, with as little curtailment or regulation as possible. Recent government actions by the EPA have restricted personal property use. It was a gross overreach that was finally settled in the courts in

favor of private property. Why the constant creep to erode freedom? One of the main reasons is that we are surrounded by those who believe themselves to be our intellectual betters who have sufficient superiority to instruct us in the use of our property. That is not freedom.

However, it is private property and should NEVER be invaded without the permission of the owner. Do you want strangers nosing through your back yard?

Palouse farms are a favorite place of ours to photograph, and the residents have been very generous in sharing photo opportunities when asked. My Co-Chairs and I have led free Field Trips for 12 years for members of the Spokane Camera Club, Photographic Society of America (PSA), and Canadian Association for Photographic Arts (CAPA). We have a Code of Ethics: Never set foot on private property without permission. Respect the rights of all property owners. Never trespass! Use a longer lens photograph from the safe edge of the road.

We Scout the Route before each Field Trip and provide participants with a safe, detailed itinerary, urge members to share images with the owners, and enjoy a warm relationship with our Palouse friends. We are proud to record the dedication and struggles of pioneer homesteaders, and NOT criticize.

Ponderosa Republican Women At the Ponderosa Republican

Women monthly meeting, Tuesday, March 11th: Chris Cargill, president and CEO of Mountain States Policy Center was our featured speaker. Chris shared information on Wonk, an easy-to-use app that is available on the MSPC website. Ask it a question and you will get concise answers regarding state bills in WA, MT, ID and WY and their impact if adopted. Chris also shared statistics on the number of legislative bills presented in WA, ID, MT and WY. To date, WA leads the pack with 1,923 bills introduced. This should be of great concern to conservatives as many of these bills are not good for WA and aim to take away the rights of tax paying citizens.

Education reform was also discussed and comparisons were made concerning the difference in what's happening in both ID and WA. ID recently passed legislation allowing parents to opt for school choice and if they opt out of public education, there are tax dollars that follow the student. Since 2015, the State of WA has accumulated \$11.3 billion in net savings where parents have opted for charter, private, home school or religious education. MSPS recommendations: expand school choice options, increase availability of public charter schools, put the school principal in charge of all aspects of their school, focus education funding on results and adopt the Public School Transparency Act.

Our next meeting will be held on Tuesday, April 8 from 11:30 to 1 p.m. at the Ruby River Hotel. Our speaker will be Marlene Pfeiffer, Chairwoman of the WA State Republican Party. Marlene will be sharing information on how other blue states have turned red and what we can do in WA to accomplish the same. Defend Faith, Family and Freedom by Taking Legislative Action! We are getting hammered in the legislature with the Senate members 30-19 and the House members 59-39. It is critical that we all stay involved. Legislature ends on 4/27/25.

The County GOP Legislative Action Committee, led by Chair Stephanie Brenden, has already started highlighting priority bills. You can sign up now for What Up Olympia? to receive periodic emails of proposed bills that especially need our attention. And, if interested, you can also sign up to be part of our Legislative Action Committee and help decide which bills should be highlighted. When you get one of the alerts, usually on Sundays, just click the links on each bill to register your position "PRO" or "CON" for the Legislative Record. You may also register to submit written testimony and/or testify remotely via Zoom during a public committee hearing'

Since our state is the only one in the nation that has become more "blue", it is especially critical that we pay attention to the bills being proposed and that we get involved in contacting our legislators when we support or oppose these bills. The Leg Committee will keep us informed on priority bills. Watch for these emails and check out information on our County and State GOP Facebook pages.
