THE VALUE OF CHALLENGING INCUMBENT POLITICIANS

Challenging incumbent politicians offers a compelling value proposition: it disrupts entrenched power, ensures accountability, and revitalizes democracy. Incumbents, often prioritizing re-election over bold action, can stagnate, clinging to outdated policies or special-interest ties.

- **Voter Choice:** Competition ensures democracy isn't a one-horse race. Even if the incumbent is competent, opposition candidates give voters options, forcing a real debate on policies and visions.

Ultimately, opposing incumbents isn't just about replacing one person: it's about safeguarding a responsive, accountable, and transparent constitutional form of government. It empowers voters, challenges complacency, and ensures elected officials serve the public, not themselves.

Remember, politicians serve We The People as stated in the United States and Washington State Constitutions.

**Republicans continue to be outvoted. We are in the minority - WA legislature; Senate 30-19 and House 59-39.*



Ponderosa Republican Women

Vicki Carter, Director of the Spokane Conservation District, was the featured speaker at our May 13 meeting. A dream come true, the first year-round farmers market and agricultural hub will open on May 31 at 4422 E. 8th Avenue, Spokane Valley, 99212.

The Scale House Market at the Quarry, <https://spokanecd.org/pages/the-quarry>, is an innovative community space located in the heart of Spokane County. It "is designed to cultivate a thriving local economy and promote a healthier community." This project transformed a landmark building into our region's first permanent, year-round farmers market and agricultural hub. The market will feature 65+ farmers/small businesses generating \$14M in annual sales, 155 new jobs; hundreds more sustained through economic activity. This site will also be a regional hub for nutrition education, events, activities and cultural experiences with 249,000 visitors annually. In addition, it will also provide equitable access facilitating \$320,000+ in annual food assistance transactions, ensuring fresh, healthy food for all. Vendor opportunities include the seasonal open-air market, year-round mercantile, commercial learning kitchen and small business support.

Vicki is also involved with Vets on the Farm, located off the Palouse Highway on Spokane's South Hill. This program engages Veterans seeking a new mission and a way to transition back into civilian life through careers in agriculture, farming, ranching or other conservation-based industries.

Our next meeting will be held on Tuesday, June 10 from 11:30 to 1 p.m. at the Ruby River Hotel. Our speaker will be Chris Corry, Eastern WA Director of the Washington Policy Center. LEGISLATIVE WATCH

Defend Faith, Family and Freedom by Taking Legislative Action!

On April 27 Washington state lawmakers passed a final operating budget, concluding the legislative session, but the process isn't complete as Governor Bob Ferguson has until May 20 to approve, veto or partially veto it. Ferguson faces pressure to veto certain tax-related legislation and possibly call a special session to address state tax policy issues.

It remains to be seen how Ferguson will act on the legislature-approved operating budget. Two other state budgets, capital and transportation, await his signature, too. "I look forward to carefully reviewing the budgets line by line over the next few weeks," he said in an April 27 statement. "When that review is complete, I will share my thoughts with the public in greater detail."

Four basic steps to the budget process: <https://www.fiscal.wa.gov/BudgetBasics/BudgetProcess>

(1) Funding requests are submitted by Washington state agencies. (2) The requests are reviewed by the governor, who then prepares a budget proposal. (3) State lawmakers look over the governor's budget plan. Next they create and debate their own budget proposal before passing it and submitting it to the governor. (4) The governor and their team examine and analyze that budget. The governor can then sign it into law or veto it - or partially veto it. Now that the budget is on Ferguson's desk, Office of financial Management (OFM) subject-matter analysts are meeting with Ferguson regularly and offering suggestions to veto or sign budget items. Legal counsel will give explanations for each veto, and the message will be relayed to the Legislature. At the next legislative session, be it special or regular, lawmakers may move to override such vetoes with a two-thirds' vote.

The Seattle Times' editorial board last week urged Ferguson to veto at least one budget-related bill, and to call lawmakers back to Olympia for "course correction" on the state's tax policy.

Budget deadlines: The governor has 20 days, not counting Sundays, to sign or veto legislation passed in a session's final days. May 20 is the deadline for Ferguson to act on the budget. Another option, however unlikely: inaction. The budget could technically still become law if Ferguson opted to let it sit there — without signing or vetoing it — past the deadline. July 1 is when the signed, "enacted" budget would take effect.
