## Abolishing the 2<sup>nd</sup> Amendment...For YOU.

Defensive Gun Use (DGU) is the use of a gun in deterrence of a crime. The gun need only to be brandished in deterrence of a potential perpetrator and is counted in some statistics.

Leftwing media and anti-American officials deliberately highlight tragic mass shootings while omitting DGU numbers. But we cannot have evidentiary debate with extremists and activists when people like former director of CDC's National Center for Injury Prevention, Mark Rosenberg said,

"We need to revolutionize the way we look at guns, like what we did with cigarettes. It used to be...a glamour symbol - - cool, sexy, macho. Now it is dirty, deadly - and banned".

Certainly the CDC has earned an "F" on Covid-19 handling but their temporary gun stance had an air of objectivity with the Gary Kleck and Marc Gertz 1995 study which extrapolated 60,000 – 2.5 million lives saved by DGU each year. However, it was no longer politically advantageous to carry such a report and in predictable fashion, was pulled by the CDC. Yet the 45,222 (including suicides) firearm death stats of 2020, remain. As we speculate on why Kleck's report is under new scrutiny; ask yourselves, why then do agencies still lend credence to its validity? - The 2013 National Academies' Institute of Medicine and National Research Council study under Obama and the 1.5 million DGU incidents estimated by the Department of Justice. - You're smart. You see what's afoot. They control the narrative; misinform the people. There is an end goal. It is more efficient for the elites to rule over us if we are unarmed.

## The Constitutional Corner

"A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed." The 2nd amendment was never about hunting nor is it really about self-defense (although that is of obvious importance). The Founders were adamant about American's ability to protect their rights. To quote Hamilton in Federalist #29, "...if circumstances should at any time oblige the government to form an army of any magnitude that army can never be formidable to the liberties of the people while there is a large body of citizens, little if at all inferior to them in discipline and the use of arms, who stand ready to defend their own rights and those of their fellowcitizens." All other arguments pale to this one. That was the intent of the Second Amendment.

This bulwark of freedom is constantly under attack, however, by those who fail to understand its absolute necessity to preserve freedom, whether you personally own a gun or not. The relentless and misguided efforts of the left to infringe on our rights to own guns, buy

ammunition, freely carry and store arms in our private residences are a daily, probing attack. It will never matter to them how many times the Supreme Court has preserved this right as inviolable, the machinations continue. Some of the most nefarious and new efforts to erode the underpinnings of the 2nd amendment include: ESG scores that grade both citizens and corporations and then strive to limit their financial transactions where guns or ammunition are involved. credit card companies collecting information about their clients on behalf of the federal government (a special purchase classification for gun related purchases that can be reported to government entities, i.e. a gun registry), federal agents requesting to "check on" the guns of private citizens without a warrant, federal agents gathering background checks that they are not allowed to access without warrants, and finally, requiring carry permits for a right that is guaranteed by the Constitution. With great power, comes great responsibility; a level of responsibility that is manifest every day, in every way, by nearly all

legal gun owners in the U.S. We have laws to regulate the purchase and use of guns that need to be enforced according to the rule of law-fairly and consistently. It is, almost without exception. criminals who commit crimes with guns, not legal gun owners. We must remain hyper-vigilant about the constant efforts to erode this right. If your bank/s are part of ESG or this new credit card purchase labeling, call them and complain. If they will not respond favorably, move your money to a bank who will. If a federal agent asks to see your guns, the proper response is, "May I please see your warrant?" The corruption in our federal agencies must be rooted out and that will only be accomplished by electing those who understand the severity of this problem and the urgent need for correction. Finally, my response to those horrific gun crimes that we all hate, is this: "The gun did not kill those people. The complacency, degeneracy and degradation of our society is killing people. Spokane residents showed up to testify on October 4<sup>th</sup> and the 3 member Spokane City Redistricting Committee voted unanimously to recommend Map #1 to the Spokane City Council for adoption. Our City is divided into three districts and with small changes, Map#1 addressed more fairly, boundaries based on population. Map #2 was opposed because it seemed biased in favor of progressives; possibly unethical since it was created by Council Member Zack Zappone, one of only two liberal Committee advisors. City Council will soon vote on whether or not to approve this map. Contacting City officials can make a huge impact! Ask them to approve the unanimous recommendation of the Committee.
