Women's Healthcare is a Euphemism for Abortion

What is healthcare? More importantly: What is women's healthcare? It is any medical care that addresses mental, physical or emotional needs specific to a woman, or, female.

Like a benign mole, removal of a fetus, which just happens to have a detectable heartbeat at 5-6 weeks, is an elective surgery and does not meet the criteria under medical need. We can therefore deduce that **Abortion is an elective surgery.**

How did we get here in such a desensitized state? We are living with people in this country who vehemently fight for the right to casually [kill] terminate an innocent growing life. If it wasn't bad enough to camouflage horrible acts with an ostensibly innocuous term, we are then scolded for not accepting abortion as a necessity. Look. Look at what we are terminating.

It is important that we all get involved and nominate excellent candidates that support our GOP principles; candidates that will have our support and can raise the funds to get elected.

My husband is in the business of health care. For the last twenty plus years we have had an up-close and personal view of the decline of our once great medical system. Healthcare - it's complicated

Health care reform has been a political slogan generator for more than a decade. Repeal and Replace! Medicare for All! Democrats tried reforming health care through the Affordable Care Act, stuffing everything into a single bloated bill. Speaker Nancy Pelosi was pilloried for saying we'd have to "pass it to know what's in it." Republicans tried repealing the whole thing, knowing it wouldn't go anywhere with a Democrat still in the White House. Small reforms passed quietly with bipartisan support. A few substantial health care bills made it out of the Republican Congress to be signed by a Democratic president. The 21st Century Cures Act, co-sponsored by Rep. Cathy McMorris Rodgers, was an example of that bipartisanship.

Then the White House changed hands in 2016.

After politicizing the massive size of the ACA and its accompanying regulations, Republicans tried an incremental strategy. Instead of one big bill to repeal and replace, there would be a series of bills, each dependent on the others to provide the complete reform but able to pass through regular order. That was the theory. In practice, it bogged down and created a lot of small targets for Democratic partisans to politicize. There's consensus on keeping Medicare for the elderly. We know there are fragile families in our communities. We want everyone to have access to health care. But nobody believes anybody's claims anymore. The truth is, the ACA did not deliver on promised savings. The new slogan is "Medicare for All!" But it has a big price tag, adding more than \$32 trillion to the federal budget in its first 10 years. The current system relies on a mix of Medicare and private insurance to cover costs. Medicare pays about 40 percent of what private insurance pays. Low reimbursements are already hurting Medicare-dependent rural hospitals. Even without expansion, Medicare is not sustainable without major changes. We still need health care reform, and there's one big idea with bipartisan support. Convincing the Senate to pass HR 372, the Competitive Health Insurance Reform Act of 2017, would be a start. Trouble is, there's no group providing pressure. Bipartisan ideas don't let anyone score points. They're complicated.

The rest of the story: "The bill attracted 20 House cosponsors, all Republicans, and was approved 416–7 by the House in March. Republicans approved the bill unanimously, while Democrats voted in favor 181–7." The bill was referred to the Senate Judiciary - and allowed to die by Sen. Chuck Grassley (R-Iowa).

WATCH FOR UPDATES IN WASHINGTON: The legislative session ends on March 8. All six initiatives have qualified for the November ballot. The legislature has three choices: 1. Pass them into law. 2. Propose another ballot measure on the same topic and both would appear on the November ballot. 3. Do nothing and they will be on the November ballot. The six initiatives are the following:

I-2113, REASONABLE POLICE PURSUIT; I-2117, STOP THE HIDDEN GAS TAX; I-2124, OPT OUT OF STATE-RUN LONG TERM CARE COVERAGE ACT; I-2109, REPEAL THE CAPITAL GAINS TAX; I-2111, NO STATE INCOME TAX; I-2081, PARENTAL NOTIFICATION. GOP Facebook page
