Tell us about yourself.

I'm a lifelong resident of Spokane County where he attended Mead schools. I earned an Associates Degree from Spokane Community College, then transferred to Whitworth University where I received a Bachelor of Arts in Business Management and later, a Masters Degree in Business Administration.

I became politically active in 2007, then I was appointed as a PCO. I worked on several campaigns during the 2008 election cycle, and continued to volunteer and work on campaigns in every election cycle since.

My involvement in the Republican Party runs deep. I have been a delegate to the precinct caucuses, county conventions, and a state convention. I am an elected PCO, was the treasurer of the Spokane County Republican Party, was the Vice President of the Spokane County Young Republicans, and was named Volunteer of the Year by the Spokane County Republican Party for my work during the 2010

elections.

Prior to serving as County Commissioner, I worked six years for the Washington State Legislature and was the Senior Legislative Assistant to then State Representative Jeff Holy. I managed Rep. Holy's campaign in 2012 and 2014, and prior to that, served in the same capacity for former State Representative John Ahern.

During my six years working for the Legislature, I split time between Spokane and Olympia. I'm a small business owner as well. I own a marketing company with my wife, Nichole. I have gained experience working both for myself and in government to be a strong advocate for small businesses in our community.

My wife and I are high school sweethearts and have been married since 2011. We have a son and daughter.

I have served as County Commissioner since 2016. I am a small business owner and from 2011-2016 I worked for the Washington State House of Representatives for Rep. John Ahern and Rep. Jeff Holy. I am an elected PCO, former treasurer for the Spokane County Republican Party, and former Vice Chair of the Spokane County Young Republicans. I helped launch the Spokane County chapter of CAPR. As County Commissioner, I have been chair of the board twice, and serve on many local and regional boards.

Describe your duty to the office you are running for and how you will achieve success.

In Spokane County, Commissioners are both the legislative and executive branch of County government. We are responsible for developing and adopting the county budget, maintaining roads and county owned buildings and property. Commissioners adopt resolutions, ordinances, and proclamations. Most importantly, we are accountable to the citizens of the County and are their representative at the County level for all issues that fall under the authority of the County Commissioners.

What does success look like for this position and what key performance indicators should voters use to evaluate you?

Success in this position is keeping the promises you make to the voters and delivering results that improve the quality of life in our community.

I have always looked for ways to deliver the services the County is mandated to in the most efficient way. I look for ways to eliminate waste and adopt budgets that are fiscally conservative and don't rely on tax increases.

It is important that we provide for our Sheriff's Department to combat crime and keep our community safe. During my time as Commissioner, I have never voted to increase property taxes.
